# MINUTES WEST VIRGINIA AIR QUALITY BOARD April 21, 1997

#### I.General

## II. Board Meeting

#### A. Administrative Matters

## 1. Parks Corporation, Appeal No. 96-14-CD

The Board reviewed the proposed final order in Parks Corporation. It was found that the signature line should be changed from Tom Ising, Chair to Mike Koon, Vice-Chair. Don Kuntz made a motion to accept the final order as amended, which was seconded by Bob Foster. The motion carried by a unanimous vote.
