MEETING MINUTES

June 6, 2006

I. General

On June 6, 2006, a quorum of the members of the Air Quality Board conducted a meeting at the Board's office located at 601 57th Street, SE, Charleston, WV. Mike Koon, Chair of the Air Quality Board, called the meeting to order at 9:00 a.m.

II. Administrative Matters

1. December Meeting Minutes

The Board meeting minutes of the December 6, 2005, were presented to the Board members for consideration. After review, Mr. Foster moved and Mr. Hudson seconded that the minutes be approved as written and the motion carried unanimously 6 to 0.

2. Fiscal Year 2006 - Purchases

Ms. Coleman reported the following year-end purchases: utility cart \$133, file cabinet \$282, and office chair for the Attorney \$402. The purchases were approved by the Board and the motion carried unanimously 6 to 0.

3. Budget Reports

The Board members were provided with a financial update through April 30, 2006. A copy of this report is attached and made a part of these minutes as Exhibit "A". Ms. Coleman reported that as of April 30th the Boards have spent 44% of the combined AQB/EQB budget which represents a ten month period, 83% of the fiscal year.

4. Purchase Card Report

Ms. Coleman provided the first quarter Purchase Card Report which details the purchases for the months of January 2006 through March 2006. The BB & T Visa card statements were also attached. A copy of this information is attached and made part of these minutes as Exhibit "B".

Whereupon, Mr. Hansen moved and Mr. Curtis seconded that the Board accept the Purchase Card Report and the motion carried unanimously 6 to 0.

Ms. Coleman explained that an Auditor from the State Auditor's Office meets with her every 3 months at the Boards'office to review the current purchase card records. This is the established audit procedure for all boards and commissions. Additionally, it was noted that Dr. Edward Snyder, Chair of the Environmental Quality Board, reviews and approves the statements on a monthly basis, unless an EQB meeting is cancelled - at which time, the statements are approved by the Chair during the next scheduled EQB meeting day. The Auditor has approved this procedure.

5. Nomination of Chair and Vice Chair

Mr. Koon discussed the fiscal year 2007 election of the Chair and Vice Chair. Mr. Calvert was nominated for the Chair position and Mr. Hansen was nominated for the Vice Chair position.

The official election will take place during the first Board meeting of the new fiscal year. In addition to the nominations, Mr. Foster informed the members that he may resign from the Board in the near future.

6. Board Meeting Dates

The Board scheduled future meeting dates as follows: July 18th, August 29th, September 5th, October 17th, November 28th, and December 19th, 2006. The Air Quality Board members suggested scheduling a joint meeting with the Environmental Quality Board in the near future.

Ms. Castillo and Ms. Radcliff provided an appeal update.
